

Rules & Regulation

1. Membership enrollment

*Memberships are available all year. Memberships purchased from Oct. 1- March 31st are FULL price. SUB MOA memberships purchased April 1- September 30th are \$700.00 and full price for MOA memberships.


*All members will be mailed a membership card with member number within 10 days of payment and completed membership form.

*All membership sales must be paid in full and are final.

*Member agrees that if a credit card charge back is performed, all items purchased through supporting companies and training classes will be charged/collected for the difference between the discount and retail pricing on ALL items and courses purchased.

*The MOA membership may be upgraded to SUB MOA at anytime of the year and will be charged the remaining balance regardless of time of year.

*Memberships may not be transferred or sold.



2. Course registration/payment

*STA member discounts for Phoenix sponsored STA courses at Ben Avery must sign up and be paid for in full 7 days prior to the course date via STA Training Group web page application enrollment form. Failure to enroll in this time period can result in loss of discount for that specific course or opportunity to attend specific course.

*All members and guests must know the firearm safety rules prior to attending any STA courses.

- 1- Treat all firearms as if they are loaded
- 2- Never point the muzzle at anything you are not prepared to shoot
- 3- Keep your finger straight and off the trigger until you are on target and prepared to fire
- 4- Be aware of your target and target environment
- 5- Keep your firearm on safe until it is being presented to the target to engage (For firearms with a mechanical safety)

*Cancellation of a Ben Avery Shooting Facility held class within 7 days of start date will be refunded 75% of total payment made.

* All courses not held at Ben Avery Shooting Facility will have the following policy. This includes but is not limited to our New Mexico and New York facilities. Course must be paid in full 30 days prior to the course to receive the STA membership discounts. All cancellations made within 15 days of




the course start date will be refunded 50% of their paid in full tuition, all other cancellations will receive an 80% refund.

*Immediate Family and nonstandard guests must register and be paid in full 7 days prior to course date via STA Training Group web page application enrollment form. Failure to enroll in this time period can result in loss of discount for that specific course or possible loss of spot in the course. Family member discounts that are taken advantage of (lying about family relationship will result in loss of membership with NO refund given).

*Friends or new shooters to STA classes are defined as a shooter(s) who have attended less than five (5) STA courses. Any shooter who has attended more than five (5) courses must pay full price or purchase a membership. Immediate family can attend at the discounted membership rate as many times as they wish and without the sponsoring member.

*STA Training Group reserves the right to dismiss any guest without refund who is late to a course. Showing up to classes after the scheduled start time is a safety issue and takes away from the other guest's training time. It will be evaluated on a case by case basis. We recommend arriving at a minimum of 15 minutes prior to start time.

*1, 8 hour private lesson for SUB MOA/MOA members and one guest (SUB MOA ONLY). Must be scheduled 10 business days prior to the specific range we are using. For example, Ben Avery is closed on Mondays. Cancellations made within 7 business days of the course starting will result in a \$100.00 cancellation fee. If the cancellation fee is not paid the private lesson will be forfeited in the membership for that year.



3. Purchasing products/course updates

*Membership discounts do not include tax and or shipping where applicable. No other discounts can be used with STA membership discounts.


*American Express cards are not authorized for purchase with US Palm products.

*Members may purchase items from the STA supporting company store fronts of any STA supporting company that allows in person sales. Members will be required to show membership IDs to complete the sale with discount.



4. Product return

*In the event of any problems with a supporting company's product purchased by the member, ALL communication and resolution will be done between the buyer and the manufacturer/supporting company. STA Training Group can and will assist in the initial communication or if no communication is being received by the member or STA supporting company.


5. Penalties/Loss of membership

*Members/Guests must meet the minimum requirements for the specific courses they attend. If a member attends a course that they are not qualified to attend, for safety reasons will be asked to leave without reimbursement. An example but not limited to; A beginner attending an advanced course and not being truthful about their minimum skill requirement.

*Violation of safety rules while in a course will result in termination of membership to courses with no refund. Sponsor discounts will be valid until membership expires.

*Integrity violations like stealing or attempting to take advantage of support company discounts will result in a full termination of membership and sponsor discounts with no refund and may be reported to authorities in the event of larceny or fraud.

*Continued unprofessional/unethical conduct will result in the termination of the membership pertaining to classes. Sponsor discounts will continue until the original membership has expired.


